

# Minutes of the Ninety-Seventh Council Meeting – 17 March 2023 Zoom meeting

Members were welcomed to the ninety-seventh meeting of the Campus Alberta Quality Council. As this was first meeting for Moira McPherson and Fred McGinn, they were welcomed to their first meeting.

After reviewing revised wording regarding criteria for nominating reviewers for program and organizational evaluation, it was MOVED and SECONDED that changes to sections 3.2 External Organizational Evaluation Team, 4.2 External Program Evaluation Team, and 5.2.4 External Evaluation Team

# for Comprehensive Evaluations of the Handbook be adopted as amended.

As a follow-up to Council's review of the quality assurance audit applications from Mount Royal University and Grant MacEwan University, at Council's 27 January 2023 meeting members agreed to review and revise sec. *5.3.5 Quality Assurance Process Audits* and sec. *5.3.6 Delegated New Program Approval Status* of the Handbook to allow institutions to apply for both statuses at the same time.

After reviewing revised wording in *sec. 5.3.5 Quality Assurance Process Audits* and *sec. 5.3.6 Delegated New Program Approval Status*, it was MOVED and SECONDED that changes to these sections of the Handbook be adopted as amended.

As the number of proposals from private for-profit and not-for-profit institutions is increasing, members began their discussion about including additional expectations for these institutions in the CAQC Handbook.

- after concluding its combined consideration with the Monitoring Standing Committee of the implementation reporting from Red Deer Polytechnic for a 4-year Bachelor of Education program, conveyed its observations in a feedback letter.
- after concluding its consideration of the proposed changes from Ambrose University's for its Business program curriculum, conveyed its observations in a feedback letter.
- after considering what information should be provided by Northern Alberta Institute of Technology with respect to its proposed new Accounting and Analytics, and Finance specializations in the Bachelor of Business Administration degree, provided its feedback to NAIT.
- after approval of Red Deer Polytechnic's proposal for a 4-year Bachelor of Arts (Multidisciplinary Studies) program by the Ministry, sent its outcomes letter to the institution.
- completed a preliminary review with respect to the University of Saskatchewan's proposal for a 4-year Bachelor of Science in Nursing program to be delivered in collaboration with Lakeland College, and conveyed its decision on a review type to the institution.
- completed a preliminary review with respect to the University of the Arts' proposal for a 4-year Bachelor of Fine Arts (Studio Arts) program, and conveyed its decision on a review type to the institution.
- began its consideration of a proposal from Mount Royal University for a 4-year Bachelor of Aviation Management program.
